

Bottineau County Fair
Exhibitor, Concessionaire and/or Vendor Rules

1. Booth/concession/vendor space is not reserved until payment and application are received.
2. A commercial exhibitor booth (inside the Exhibit Hall) includes one complimentary four-day gate pass. Additional season passes may be purchased at \$30 each, or \$10 per day at gate. All other vendors/concessionaires are required to buy a pass.
3. Each booth display includes one 6 foot table (not draped) two chairs, and a drapery backdrop.
4. **All food vendors are responsible for your own garbage and waste products from your stand. If you use cooking oil in your stand, please take with you. It is not the responsibility of our local businesses to handle your oil/grease after the fair.**
5. Booths must be manned at all times. Bottineau County Fair staff and management are not responsible for lost or stolen goods or materials. Each commercial exhibitor is responsible for his/her own materials.
6. This privilege to exhibit/sell at the Bottineau County Fair may be revoked at any time. Location will be assigned by the Fair. In case of known violation of Fair rules and regulations, or state or U.S. Laws, the renter forfeits all right to this exhibition privilege without relief from any paid portion of the price, or repayment of the same, and upon notice by Fair officials he/she agrees to vacate the grounds or locations occupied by the stand and cease to do business without demure.
7. Renter shall not use any amplifying device without the approval of the Fair.
8. It is mutually agreed that the general rules and regulations as set forth in the official premium book of the Bottineau County Fair for the current year shall govern and apply to the operation of the exhibit or concession privileges hereinafter granted.
9. Set up hours: Booths/concessions/vendors should be set up by Thursday at 10:00 am. Grounds open at 8:00AM.
10. Exhibit Hall Hours:
 - a. Thursday: 10:00 am to 10:00 pm
 - b. Friday: 10:00 am to 10:00 pm
 - c. Saturday: 10:00 am to 10:00 pm
 - d. Sunday: 10:00 am to 6:30 pm
11. Release Time: Sunday at 6:30 pm. All booth materials must be removed by 10:00 pm
